	When employees request an Absence through Employee Self Service (ESS) Request Absence or Add an Absence Event, managers will receive an e-mail stating that there is an absence request that needs their approval.
	Previously the manager either did not receive an e-mail or received an e-mail stating that the timesheet needed approval, depending on the method used to enter the absence.

	<ul> <li>No Time Off (NTO) scheduled hours will now default when monthly employees submit their timesheets, alleviating the need for manual NTO entry or setting schedule preferences.</li> </ul>
	<ul> <li>If an Absence or Holiday is present, NTO will populate based on scheduled hours minus the absence hours or holiday hours.</li> </ul>
	<ul> <li>The process will now return a message to employees at the time of submit stating that " payable time will be available for approval after time administration has completed."</li> </ul>
	• Elapsed Timesheet: Time Reporter Code selection and add/delete row have been moved to the left of the timesheet for greater visibility.
