Users will need journal generate and post journals in Financials based on Institution business process.

Note:

- The PUBLISH (BORPSBPA) process that loads FIN journal data back to OneUSG Connect PERS_SERV_BOR (PSB) table runs at 4 a.m, 8 a.m., 12 p.m., 4 p.m. and 8 p.m.
- After you journal generate, OneUSG Connect journal data in all PSB queries will be blank until the publish process completes.
 - $_{\odot}$ PSB in Georgia FIRST Financials is the last table to be populated thru the PUBLISH process.
