Voucher Post Batch Process	Navigation: Accounts Payable > Batch Processes > Vouchers > Voucher PostingWhen selecting a Post Voucher Option and searching for a Business Unit, users were able to view all Business Units/Set IDs in the Post Voucher List section.Now, the Voucher Posting Request page is secured by Business Unit/Set ID such that users can view their Business Unit/Set ID only.
Document Tolerance Batch Process	Navigation: Accounts Payable > Batch Processes > Vouchers > Document Tolerance When selecting a Run Option and searching for a Business Unit, users could view all Business Units. Now, Document Tolerance Run Control is secured by Business Unit such that users can view their Business Unit only.
