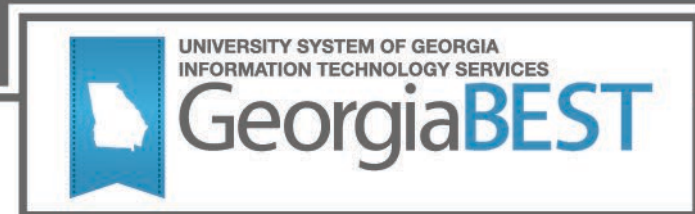

Apply Financial Aid Release 1.2 to your TEST Banner database.

### **Step 2**

Turn on the ITS version of GlobalProtect VPN (for beta testing only). For download, install and login instructions, email [DW\\_Test@usg.edu](mailto:DW_Test@usg.edu).

### **Step 3**

Run the USG Extract in the TEST environment using the following URL:

- VFNA046 - If populated, then Pell Lifetime Limit Flag must be C, E, H or N.
- VFNA047 - If student has EFC, then Subsidized Usage Limit Applies Flag cannot be null.
- VFNA048 - Subsidized Usage Limit Applies Flag must be Y or N.
- VFNA049 - If student has EFC, then Subsidized Usage Period cannot be null.
- VFNA050 - If populated, then Undergraduate Subsidized Loan Limit Flag must be C, E, N or R.
- VFNA051 - If populated, then Undergraduate Combo Loan Limit Flag must be C, E, N or R.
- VFNA052 - If populated, then Graduate Subsidized Loan Limit Flag must be C, E, N or R.

### Test Scenario 1:

1. In Cognos, click the Validation Error Summary link on the left side of the page under the heading, Validation Errors.
2. Using the drop down box under the heading, FADC Errors – System Summary, select Severity Level Error. If errors are listed in the Total Errors column, click the link to view the listing of errors by Category, Record Type and Business Rule Code.
3. For each Business Rule Code, click the View/Download link to view a detailed listing of errors.
4. For each Business Rule Code, review the validity of each error code by reviewing the Attribute Content for a sample of errors.

  - Table Dump – Student Funds
  - Table Dump – Student Institutional Funds
  - Table Dump – Student Summary
  - Trend Report - Institutional Funds
  - Trend Report – Student Funds

### Test Scenario 2:

1. In Cognos, select the Institution Summary by Award Year report from the menu on the left side of the page under Data Collection Review.
2. Verify that the Total number of students and Total number of students with \$ amount > 0 are accurate.

### Test Scenario 3:

1. In Cognos, select the Table Dump – Student Cost of Attendance Detail report from the menu on the left side of the page under Data Collection Review.
2. Verify that the BUDGET\_TYPE\_CODE, BUDGET\_COMP\_CODE and BUDGET\_COMP\_DESC match the codes and descriptions used by your institution.
3. For a sample of students, verify that the budget component codes, budget component descriptions and budget component amounts are correct.

### Test Scenario 4

1. In Cognos, select the Table Dump – Student Summary report from the menu on the left side of the page under Data Collection Review.
2. Verify the presence of the following added columns:

  - NSLDSPELL\_LEU
  - NSLDSPELL\_LEU\_LIMIT\_FLAG
  - SUB\_USE\_LIMIT\_FLAG

### **Test Scenario 5**

1. In Cognos, select the Trend Report – Institutional Funds from the menu on the left side of the page under Data Collection Review.
2. Review the Institutional Funds Two Year Comparison Report to confirm that data is accurate.

### **Test Scenario 6**

1. In Cognos, select the Trend Report – Student Funds from the menu on the left side of the page under Data Collection Review.
2. Review the Regents Funds Two Year Comparison Report to confirm that data is accurate.
3. Select the HOPE/PELL/ZELL tab at the top of the page, select HOPE in the drop down box, and click the Finish button. Verify that the data for HOPE funds is accurate.
4. Select ZELL in the drop down box and click the Finish button. Verify that the data for ZELL funds is accurate.
5. Select PELL in the drop down box and click the Finish button. Verify that the data for PELL funds is accurate.

### **Test Scenario 7**

1. In Cognos, select the Trend Report – Student Summary from the menu on the left side of the page under Data Collection Review.

2. Verify that the data for each aid year is correct and that the percent change columns calculated correctly.
