

Addition of new Fund Codes for REACH Scholarship

- Two new fund codes have been added for the state need-based REACH scholarship.
 - REACHD REACH Disbursed Scholarship, Realizing Educational Achievement Can Happen - Disbursed
 - REACHU REACH Undisbursed Scholarship, Realizing Educational Achievement Can Happen - Undisbursed
- The first term these awards were available was Summer 2017.
- The maximum award amount per semester has been set at \$1,250.



Retirement of RORCALC prerequisite

- The requirement to execute the Calculated Values Process (RORCALC) for the Financial Aid data submission has been lifted.
- Instead, the extraction process will pull the necessary information from RNVANDO, a view within Banner.



Changes to the Financial Aid Data Element Dictionary (DED)

A variety of changes have been made to the Financial Aid Data Element Dictionary.

- Correction of grammatical errors
- Addition of Banner source information
- Correction of capitalization in certain sections of the DED



- Three groups of new validations have been added to the Financial Aid data submission process.
 - Group 1: New validations help the end user to identify fund amounts submitted during the current aid year which are different from the fund amounts submitted during the past aid year by a certain percentage.
 - Group 2: New validations alert the end user that no data has been submitted for a given fund code.
 - Group 3: New validations verify that at least one Social Security Number has been submitted and that all tables have populated as expected.
