The Study abroad committee was called to order at 10:00am

OIE Office Update

- -BOR's goal is to reach 25% of baccalaureate degrees for students to study abroad.
- -Currently at 21%
- -Want to reach goal by 2012
- -Graduation rate increases with study abroad students, currently the statistic is out of 25,000 graduates the rate increases to 89% graduation rate. Further supports the argument for study abroad.
- -There is a current audit for study abroad programs which will help establish rules when creating programs.
 - -There are two levels of audit: a system-level audit, and a campus level audit.
 - -Looking for BOR approved programs that have been documented.
 - -Also looking for accurate study abroad program budgets.
 - -No tuition cost should be paid out of the program cost.
- -Audit meant to be a constructive examination of study abroad programs, and a way to standardize programs throughout the state.
- -Argument against audit is that because study abroad programs are unique in nature if we try to standardize the programs university presidents might not support the programs.
 - -Estimated time for this development may take up to two years.
- -Start at BOR, move to institution, then to internal, then back to BOR to discuss state regulations.
 - -Hopefully will unify 35 institutions in the state of Georgia.
 - -STARS Program
- -Because of budget cuts, the BOR has not released an accurate amount for STARS funding and currently does not know when the statement will be released.
 - -Note for future agenda discussion: how to manage STARS awards for Fall programs.

- -In order to promote a program in your online catalogue, it has to be BOR approved.
- -BOR is thinking starting a hotline for the public regarding issues from study abroad programs.
 - -Note for future agenda discussion: how to calculate credit on short term programs.
 - -Don't forget to send STARS awards report.

Risk Management Discussion

- -A draft of the risk management procedures was handed out to the committee.
