Dear Presidents:

The Board of Regents (BOR) of the University System of Georgia (USG) met on April 17 and 18, 2018 at the Georgia Institute of Technology in Atlanta, Georgia. During this meeting, many policies were revised as part of the ongoing Policy Review Initiative. The purpose of the review process and the revisions made are to increase efficiency of, to ensure consistency in, and to simplify the BOR Policy Manual.

These policy revisions will continue through the May 2018 Board Meeting, and we anticipate edits to many more Board policies. As such, we recommend that you hold off on updating your campus policies until the completion of the Board Policy Review Initiative in May.
