

**MINUTES OF THE SPECIAL TELEPHONIC MEETING OF THE  
BOARD OF REGENTS OF THE UNIVERSITY SYSTEM OF GEORGIA  
Held in Atlanta Georgia on May 30, 2014**

**CALL TO ORDER**

The Board of Regents of the University System of Georgia met by telephone conference call on Friday, May 30, 2014. The conference call originated from Room 7019 in the Office of the Chancellor, 270 Washington Street, S.W, in Atlanta, Georgia. The Chair of the Board, Regent Philip A. Wilheit, Sr., called the meeting to order at approximately 2:30 p.m. Present, in addition to Chair Wilheit, were Regents C. Dean Alford, Lori Durden, Rutledge A. Griffin, Jr., Donald M.
