- 5. Know More, Borrow Less Initiative: Should help students fill FAFSA forms more quickly; should help students understand how loans work.

Follow-up on FLAAC's previous questions:

- Many students minor in FL. How can the data be displayed to BOR? USG does not collect minor data. Data governance teams have discussed this in the past with no resolution. Data may be collected at the institutional level. Difficulty moving students through a 4-semester sequence. Minor a better option, but this will need to be tracked at the institutional level. Can be annotated and tracked in Banner at the institutional level.
- 2. Questions about American Studies minor from Lisa. FL creates challenges for other majors because of the necessary sequencing of FL courses.
- 3. FL courses are available all year long and can be completed off the normal Fall/Spring cycle. Advisors need to promote FL study early on.
- 4. Dual Enrollment courses creating problems for some institutions.
- 5. Problems with counting 1001 & 1002 in Core. If a Major requires FL 2001 and 2002 in Area F, they must also allow for 1001 and 1002.
- 6. Georgia Coastal History BA proposed 1001 & 1002 only for the major.
- 7. What is the difference between a BA and a BS? The USG should redefine BA and BS.
- 8. Unfunded prerequisites
- 9. 1001 and 1002 can be offered in Area C (per Barbara Brown).
- 10. Marty Venn in the USG can help us define BA/BS. Historically these have been difficult to define.
- 11. Transferability of courses is the main issue for our committee
- 12. Tracy Ireland at the System Office is the expert on what can be financed by Financial Aid (minors, "unfunded prereqs," etc.).
- 13. What can be the USG's role in requiring FL or even strongly supporting FL.

Language Placement

- 1. Perhaps FLAAC could create a document that outlines the way each institution places students into courses.
- 2. Some institutions charge for placement tests, some do not. Some use WebCape, which is free for students but costs the institution.
- 3. How does each institution handle native/Heritage students?
  - a. a. Cannot force them out of lower-division courses.
  - b. b. Can utilize them as "tutors" in the class; can use differentiated instruction (some instructors find this approach problematic)
  - c. c. Explain the nature of the course on the first day and make clear that Heritage speakers will be required to do all the "menial" work and attend every day.
  - d. d. Should 1001 be offered for P/F only?
  - e. e. Consider putting into course catalog descriptions that prohibit students from taking the course if their linguistic proficiency exceeds that of the goals of the course.

eLanguage Consortium (Ofelia Nikolova: Valdosta)

- 1. eMajor becomes tri-institution consortium (Valsdosta, Clayton, Coastal Georgia)
  - a. Advantages: Shared resources, diverse voices, ability to offer full BA

- b. Current programs:
  - i. Certificates: TESOL, ESOL Endoresement, Spanish for Professionals
  - ii. Majors: French, Spanish
  - iii. Minors: French, Spanish
  - iv. Latin: Language sequence
- c. Delivered via GoVIEW
- d. Grades via INGRESS
- e. Course evals via Qualtrics survey
- f. Faculty vetted by teaching institution
- g. Tuition: 80% to instructor's institution, 20% to student's home institution
- h. MOU required. Any institution can join by signing an addendum
