Institutions would be free not to use the template. The template provides a pre-approved option, but does not oblige institutions to offer such a course.

A motion was made and seconded to form a subcommittee to explore developing a templated course for HUMN 1000. The motion carried with 17 votes. Berlethia Pitts, Allen Dutch, and Paul Dahlgren volunteered to serve on that subcommittee.
