- Comprehensive Program Review Task Force
 - Program Cost
 - Reviewed various papers and models
 - Concluded there is no one-size-fits-all method
 - Program Cost = Pandora's Box
 - Common Metrics
 - Gathered data from peers
 - No clear 'universal' set, but many possibilities
 - Next Steps
 - Have members on USG Task Force
 - Will have charge and general sense of system needs after meeting in November
 - Next task will be to contribute to work emerging from task force
