The Council reviewed a request from Marci Middleton to consider the issue of calculation and transferability of a cumulative versus an adjusted GPA, especially as it relates to admission to an honors program. The Council recommended that since the issue appeared to be one of institutional autonomy, it should be referred to the chief academic officers for consideration.

Assistant Vice Chancellor Kris Biesinger gave a general introduction to the eCore—where the idea originated, who is involved, how does it work, etc. The Council asked to review eCore courses at some time during their development to ensure that they meet core requirements. Dorothy and Kris agreed to develop an approval process for eCore courses, consistent with what occurs on a campus, prior to forwarding courses to the Council for approval.

The Council also agreed to examine course materials of existing eCore courses prior to its Spring 2004 meeting.

Dorothy distributed copies of AAC&U's National Panel Report titled "GREATER EXPECTATIONS: A New Vision for Learning as a Nation Goes to College" to all the Council members. Certain sections of the Report will be discussed at future meetings. Copies of "Thinking P-16" were also distributed to all members.

Council members thanked Tom Fox for hosting this Council meeting and for the very gracious hospitality of North Georgia College & State University.
