Discussion items

- Consideration of AP scores: The Council discussed the charge to the academic committees from Dan
 Papp regarding the diversity in practice across the System in awarding AP credit. Most but not all of the
 academic committees have submitted recommendations, so we are still waiting for responses from all
 appropriate committees.
- 2. Relationship of Area A and D mathematics courses: At the March 2005 meeting, the Council recommended that we ask the Academic Committee on Mathematical Subjects to consider and clarify the relationship between the mathematics courses in Areas A and D, taking into consideration Math 1001. In light of some additional information, the Council will ask ACMS to reconsider the issue.
- 3. Since there have been several reports of institutions not following the core curriculum framework and not adhering to core curriculum guidelines, the Council will embark on a review of core curriculum materials posted on institutional web sites. Reviews are due to Dorothy by August 1, 2005.

The Council thanked Dorothy Zinsmeister for hosting the meeting. The next meeting is scheduled for October 2005.
