Other business:

- 1. The Council welcomed Dr. Virginia Carson, VPAA at Georgia Highlands College, as the chair of the Council.
- 2. The Council again endorsed the policy of not allowing orientation courses as part of the degree requirements in the core curriculum. Institutions wishing to offer orientation courses may do so, but they must be outside of the required 120-hour degree program.
- 3. eCore discussion—The Council assumed that institutions that adopted the eCore as a second core used existing campus processes to approve it. Apparently, this was not always the case. The Council again reiterated that it would like to receive from the eCore Committee a submission of courses they plan to develop. The Council would like to review them before eCore expends time and energy developing them.
- 4. May a USG institution refuse to accept an eCore course in transfer? The answer is NO.
- 5. Dr. Carson asked the Council for input into the Strategic Planning Initiative on General Education. Many suggestions were made that addressed the role of the Council in the process, transferability, assessment plans, student learning outcomes, measures of quality, role of faculty development, purpose of Area B, student-centered view of the curriculum, among others.
- 6. In order to facilitate communication across the System, the Council recommended that Council Actions be posted on the Core Curriculum web page. Dorothy will follow through on that request.
- 7. The Council congratulated Virginia Carson on her first meeting. The next meeting is scheduled for Spring 2006, its location TBA.

The meeting adjourned at 11:30 am, October 25, 2006.

Updates:

- 1. The Academic Committee on Mathematical Subjects (ACMS) is discussing the idea of recommending MATH 1113 as a requirement in Area A for middle grades teachers with a concentration in mathematics.
- 2. Georgia Gwinnett College will soon be submitting their core curriculum for approval by the Council. This is in preparation for submission by GGC to SACS for candidacy.
- 3. The next scheduled meeting of the Council will be in Spring 2007. Dates and place will be determined later.
