Discussion items:

- 1. Virginia Carson opened the meeting by providing an update on the approval of the core curriculum at GGC. The VPAA agreed to respond soon to our recommendations made in April 2007.
- 2. The Council provided general feedback on some courses that UGA plans to submit to the Council for consideration and approval for the core curriculum. Joe Crim volunteered to provide a crosswalk between USG and UGA "areas" of the Core. He also agreed that information related to items 10 and 11 of the USG Core Curriculum Proposal Form is essential to the review process.

The council also recommended that a discussion of UGA's core curriculum be placed on the next RACAA agenda-- specifically the actions that the Council has taken, and UGA's agreement with respect to students who transfer *to* UGA.

As was noted at an earlier meeting, there still needs to be discussion and resolution on the issue of credit transfer for students who transfer *from* UGA to another institution.

3. Dorothy agreed to act on the Council's recommendation that Learning Support prerequisites be added to the Proposal Form.

The Council thanked Virginia Carson for a well-run meeting.

The Council discussed May or June 2008 for its next scheduled meeting. Dr. Carson will poll the group for suggested dates.
